Direct Recruitment of Sports Personnel against Sports Quota

Food Corporation of India (hereinafter termed Corporation), one of the largest Central Public Sector Undertaking, dealing with Food grain supply chain Management, intends to recruit 02 (Two) meritorious sportspersons as Assistant Grade III (General) in IDA Pay Scale of Rs. 28,200-79,200/-. Applications are therefore invited from Indian National fulfilling the prescribed qualification, experience; age etc. for discipline indicated below:

Age Limit: Between 18-27 years as on 01.08.2022. (The Maximum age limit can be relaxed by 5 years in case of SC/ST candidates and 3 years for OBC candidates).

Educational Qualification: Graduation in any discipline from recognized university with proficiency in computers (Relaxable in case of exceptionally outstanding sports personnel)

Eligibility: In any of the above disciplines, the person should, in the year immediately preceding his application for recruitment in the Corporation should have represented:

- A university in the Inter University Tournament conducted by the Inter University Sports Board: and/ or
- A combined University team in the National and World Universiad International competition; and /or
- 3. A State in the National competition; and /or
- The country in any International competition.

Note: Certificates awarded by the authorities mentioned hereunder in the prescribed format applicable will alone be taken into account while considering the eligibility of an applicant.

How to Apply :

- Candidates should satisfy themselves that they fulfil the required eligibility, education qualification, age, etc. before applying for the same.
- Application shall be neatly typed/ filled in the prescribed format in A-4 Size paper.
- Self attested photocopies of all the required documents in support of age, qualification, sports achievement, caste etc. are to be attached with application form. Original Certificates would be scrutinized at the time of interview/ selection trial.
- Applications complete in all respect and duly signed by the applicant should be placed in a scaled envelope.
- The envelope should be superscribed as "APPLICATION FOR THE POST OF ASSTT. GRADE III (GENERAL) UNDER SPORTS QUOTA- Discipline (CRICKET/ TABLE TENNIS)"
- 6. The envelope containing the application alongwith documents complete in all respects be sent by ordinary/speed/registered post to :-

- The applications should reach at above address by 07.02.2023. For candidate belonging to J&K and NE States, last date for receipt of applications will be 14.02.2023.
- The applications reaching beyond the above mentioned last date will not be accepted.
- The Corporation will not be responsible for postal delay or delay due to any other reason.

Selection Procedure :-

Applications received up to the prescribed date will be scrutinized by Food Corporation of India. Shortlisted candidates will be called for selection trials and verification of original documents. No TA/ DA will be admissible for selection trials and verification of originals documents.

General Condition:

- Employees of Central/ State Govt. /Public Enterprises should forward their applications through proper channel to reach the Corporation before the last date notified. Direct applications in such cases will not be entertained.
- The Corporation may, at its discretion, relax qualification and age in appropriate cases in accordance with the rules.
- Mere submission of an application and fulfilling the eligibility criteria would give no right to any person for selection trial.
- d) All appointments will be subject to the Rules and Regulations of the Corporation and/ or directives of Govt. of India, amended from time to time.
- e) The above mentioned posts carry IDA pattern pay scale and usual allowances such as DA, HRA, etc. Other benefits like CPF, Gratuity, Pension, Leave Travel Concessions, Leave Encashment, Medial Reimbursement, Conveyance Reimbursement etc. shall be applicable as per the rules of Corporation as amended from time to time. Gross emoluments would vary depending upon place of posting.
- The Prescribed qualification, eligibility, age limit etc. shall be reckoned as on 01.08.2022.
- Any attempt to influence the Corporation in any manner would disqualify the candidature and lead to rejection of his/ her application.
- No correspondence will be entertained about the outcome of the application.
- Application not in the prescribed format and/ or incomplete applications shall be summarily rejected.
- The decision of FCI authorities in all matters related to acceptance or rejection of the application, mode of selection etc. will be final and binding to candidates.
- Selected candidates will be liable to be posted anywhere in FCI East Zone, consisting of West Bengal, Sikkim, Bihar, Jharkhand & Odisha State.
- Selected candidates will have to execute a Bond of Rs. 1,00,000/- (Rupees One Lakh Only) for serving the Corporation for a minimum period of 3 years.
