2. These posts will be filled up on loan basis from amongst the officers working under GST & Customs formations and from amongst officers holding analogous posts in the Directorates under CBIC in the same pay scale.
3. **The period of loan is initially for two years and can be further extended for one year** at the discretion of the Competent Authority with the concurrence of the cadre controlling authority concerned. Further, as per Board letter F.No. A-11013/12/2019-Ad IV dated 27.05.2020, in exceptional circumstances, for justifiable reasons, the Board may extend the tenure of the officers beyond the 3 years.
4. Applications of interested officers may be forwarded by the CCAs to the Pr.ADG, NACIN Jaipur at e-mail id ([nacinzti-jai-rj@gov.in](mailto:nacinzti-jai-rj@gov.in)) **along with History of Posting, APAR grading up to the previous 3 years, Vigilance Certificate and "No Objection Certificate" from the concerned CCAs latest by 13.03.2023. Advance copies of the applications, without 'NOC' from the zonal CCAs, will not be considered.**
5. In case, the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent organization even before the completion of the loan period.
6. Selected officers will have to make their own arrangements for residential accommodation.
7. The officers selected will continue to draw their salary and other allowances from their parent organization, as per rule.
8. It is requested that the notice may be widely circulated amongst the eligible officers under your jurisdictions.
