- 2. These posts will be filled up on loan basis from amongst the officers working under GST & Customs formations and from amongst officers holding analogous posts in the Directorates under CBIC in the same pay scale.

The period of loan is initially for two years and can be further extended for one year at the discretion of the Competent Authority with the concurrence of the cadre controlling authority concerned. Further, as per Board letter F.No. A-11013/12/2019-Ad IV dated 27.05.2020, in exceptional circumstances, for justifiable reasons, the Board may extend the tenure of the officers beyond the 3 years.
