- 3 The applications not in the prescribed format will summarily be rejected.
- 4 Number of vacancies are likely to vary.
- 5 Above position is for ad-hoc extramural research projects purely on temporary basis and co-terminus with the project.
- 6 Recruitment will depend upon requirement of project and subject to approval of the competent authority.
- 7 The rates of emoluments/ stipend are project specific and may vary according to sanction of the funding agency of the project depending on availability of funds.
- 8 Age Concession: Age relaxation is admissible in respect of SC/ST/OBC candidates, project employees and ex- Serviceman in accordance with the instructions issued by ICMR from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons, subject to approval of competent authority.
- 9 Cut-off date for age limit will be as on the date of walk-in-interview.
- 10 Reserved category candidates must produce their Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate.
- 11 Qualification and experience should be in relevant discipline / field from an Institution of repute. Experience gained after acquiring the minimum essential qualification will only be considered.


