- 1. Walk-in interview will be applicable for the vacancies remain available as on the date of interview. The vacancies available will be published on completion of every month of the walk-in interview.
- 2. The aspiring applicants satisfying the eligibility criteria in all respects can appear for the walk-in interview as per the days mentioned above. However, One candidate can appear for the interview only once in a month.
- 3. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria in all respects as on the date of interview

Important Instruction:

- 1. The Physical disability of finally selected candidates would be ascertained by a Medical Board of the Institute specifically constituted for this purpose, if deemed necessary.

ELIGIBILITY CRITERIA FOR THE POST OF FULL TIME/ PART TIME SUPER SPECIALIST

Upper age limits will be 65 years as on the date of interview.

- i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College/ Institution.
- ii) DM/MCH in respective Super Specialty from MCI/NMC recognized Medical College/DNB in concerned super specialty or equivalent.
- iii) Should have registered with MCI/NMC or State Medical Council.
- iv) Five years' experience in the concerned specialty after obtaining the First Post Graduate degree.
- v) The Academic Qualification in the department of Reproductive Medicine & Surgery is detailed as below:

Note:-

- Candidates with at least five years post super specialty qualification experience will be considered for engagement as Consultant (Senior Level).
- Qualifications with regard to experience are relaxable at the discretion of the Appointing Authority on recommendation of the Selection Committee in case of candidates otherwise well qualified.

Emoluments for the Post of Full Time / Part Time Super Specialist

For Full Time Super Specialists: -

- 1. Super Specialist (Entry Level) Rs. 2,00,000/- (Consolidated remuneration) per month. No other allowances in any form shall be admissible.
- **2.** Consultant (Senior Level) Rs. 2,40,000/- (Consolidated remuneration) per month. No other allowances in any form shall be admissible.

- 2. Consultant (Senior Level) Rs. 1,50,000/- (Consolidated remuneration) per month for 04 hours per day & 04 days in a week.

In addition **Rs. 20, 000**/- per month for visiting charge in case of emergency visit and **Rs. 1200**/- for every additional hour of **Super Specialist (Entry Level)** and **Rs. 1500**/- for every additional hour of **Consultant (Senior Level)**. The additional hour of work will be decided by the MS / Dean. No other allowances in any form shall be admissible.

Terms & Conditions for Full/Part Time Super Specialist

- a) In case of Full time Super Specialist, the engagement will be for a minimum period of **one year** or till regular incumbent joins, whichever is earlier. The contract would be extendable yearly based on satisfactory performance.
- b) In case of Part time Super Specialist, the engagement will be for a period of **one year** or till regular incumbent joins, whichever is earlier.
- c) In respect of candidates engaged under full time basis, private practice of any kind will not be allowed.
- d) In case of selection, the engagement in respect of Full time/Part time Super Specialist is up to the age of 67 years or the contracted period whichever is earlier.
- e) The Super Specialist shall be available on call 24x7.
- f) The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.
- g) The Selected Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakh for Anesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc. (2) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc. (3) for Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs. 10 lakhs. A copy of the Insurance & Premium and receipt must be submitted within 7 days from the date of engagement.
- h) Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
- i) The Full time Super Specialist is entitled for the leave @ 04 days for each month of work on a prorata basis in a calendar year. In the event, the Super specialist prefers not to avail the leave; the same may be encashed to a maximum limit of 30 days.
- j) The Part time Super Specialist will not be entitled for any kind of leave benefits.
- k) The appointment is subject to Medical Fitness.
- 1) No TA/DA will be admissible for attending the interview/joining the post.

- m) The selected Full Time/Part Time Super Specialist will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
- n) The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
- o) Candidates applying in **OBC/SC/ST/EWS/PWD** Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which he/she can be treated as UR Candidate.

- r) EWS candidate appearing for the post must have EWS certificate as per Govt. prescribed format and valid on the date of interview.
- s) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
